

CANVASS of November 6, 2019 Election

The Powhatan County Electoral Board Canvass was called to order at 9:12 AM. Josephine Goodman moved to close the meeting to the public pursuant to section 24.2-653(B) of the Code of Virginia for the purpose of considering said Provisional Ballots. On the second of Frank Flannagan, the votes were 3 ayes, 0 nays. No provisional attendees were present.

Said meeting doors were closed and the provisional ballots were discussed in precinct order. The Director of Elections reported 12 provisional ballots had been cast on Election Day. The Provisional ballot was reviewed. The provisional meeting will be reconvened at 4:00 pm on November 7, 2019.

The Board reconvened in open session. The doors were opened and observers were invited to return.

Mr. Flannagan moved that the Electoral Board of Powhatan County certify that in the closed session just concluded the only matters discussed were the qualifications of the provisional voters, as directed by Section 24.2-653 of the Code of Virginia, and as identified in the motion to close the meeting pursuant to the Virginia Freedom of Information Act.

Mrs. Goodman provided the second and called the roll:

Mr. Flannagan voted AYE
Mrs. Goodman voted AYE
Mrs. Weber voted AYE

The Board began the Canvass of each precinct's vote. Chairman Flannagan moved to recess at 4:04 pm to resume Canvass at 4:00 pm on November 7th, 2019. Mrs. Weber seconded and all voted AYE

The Board reconvened on November 7th, 2019. Chairman Flannagan called the meeting to order at 3:58 pm. There were 13 Provisional Ballots to be reviewed. Mrs. Goodman moved to accept five ballots and reject six ballots.

The Board reviewed the write-in results for Soil and Water.

Mrs. Goodman moved to close the session due to 24.2.653. Mrs. Weber seconded. All voted in favor.

Frank moved to recess until 1:00 pm on November 8th and the meeting was adjourned at 5:35 pm.

Frank reconvened from recess at 1:00 pm on November 8th, 2019. Mrs. Alexander presented two ballots that were pending identification. Mrs. Goodman moved to accept one ballot and reject another. Mr. Flannagan seconded, the board voted all in favor.

The Board updated the vote count and Mrs. Alexander prepared the paperwork to certify the election results. The Board signed the paperwork and Mrs. Weber sealed the results.

Mrs. Alexander thanked the Board for their help. The Board reciprocated with their thanks for Mrs. Alexander and Mrs. Swemba's amazing work for the citizens of Powhatan County.

Mr. Flannagan moved to adjourn the meeting and close Canvass at 1:31 pm. All voted in favor.
