**ORDER**

2. The criminal bench days on the second Tuesdays of odd numbered months are suspended effective November 1, 2024.
3. Term days shall begin at 9:00 a.m.

All remaining provisions of the Local Rules published in Rule 1:15 shall continue without amendment.

The clerk shall forward this Order to all interested parties and post this Order at the Courthouse and on any on-line page for the Powhatan Circuit Court.


